## **Preventive Measures Foundation Legacy Scholarship**

Award Amount: \$2,000 each to 45 selected applicants

Scholarships are awarded based on academic performance, leadership potential, participation in extracurricular or community activities, letters of recommendation, and evaluation of essay submission.

### **Eligibility Requirements**

#### 1. Residency or Enrollment

 Applicant must be a resident of, or attending college in, Pennsylvania, Georgia, or the Washington, DC Metropolitan Area (DMV) OR must be attending a recognized Historically Black College or University (HBCU).

#### 2. College Enrollment

- Applicant must be entering or currently enrolled in an accredited college or university.
- If you are a current student, you must confirm you will be attending your **current** college in the upcoming fall semester.
- If you are transferring, you must submit a letter of acceptance from your **new college for the upcoming fall semester.**
- If you are graduating **before the next fall semester** and not pursuing a higher level of education (e.g., PhD), you are **not eligible.**

#### 3. Field of Study

 Applicant must provide a letter of acceptance to an accredited degree program with a major in the area of **Human Services** (Psychology, Counseling, Social Work, Sociology, Medicine, Nursing, Home Health, Public Health, or Public Administration).

#### 4. Academic Performance

- Minimum 2.50 GPA required.
- Freshman applicants must provide a **final high school transcript**.
- Current college students must provide a **full college transcript**.

#### 5. Letters of Recommendation

• Two (2) formal letters of recommendation with contact information must be submitted in PDF or Word format.

#### 6. Essay Requirement

- Submit a 500-1000 word essay on the topic: "My Impact on Humanity", describing how you will use your Human Services degree to positively impact humanity and your community.
- Essays must be typed, double-spaced, and submitted as a **PDF or Word document.**
- Applications with essays under 500 words will not be considered.

### 7. Additional Requirements

- Upload a **recent headshot** (for promotional purposes).
- Provide a valid email address and phone number for your school's Bursar/Financial Aid Office (scholarship funds are disbursed directly to schools by wire transfer).

#### **Important Notes**

- Scholarship payments are only disbursed by wire transfer. If your college or university does not accept wire transfers, you are ineligible to apply.
- If you graduate in May and are not pursuing further education in the following fall semester, you are not eligible.
- Students who are transferring must provide an acceptance letter from their new institution for the upcoming fall semester.
- Refunds from schools for students who graduate early or do not remain enrolled will be returned to the Foundation.

## PM LEGACY EMPLOYEE ELIGIBILITY REQUIREMENTS

### Preventive Measures Foundation - Employee & Contractor Scholarship Policy

## 1. Purpose

The Preventive Measures Foundation (PMF) provides scholarship funds to support the professional and career development of its employees and contractors. This policy outlines the eligibility requirements, application process, and terms of acceptance for the **Employee & Contractor Scholarship Program.** 

## 2. Scholarship Amount

- Employees and contractors are eligible to receive up to \$1,000.00 in scholarship funds.
- Employees and contractors enrolled in a Human Services degree program are also eligible to apply for the \$2,000.00 PM Legacy Scholarship (see PM Legacy Scholarship eligibility requirements for details).

### 3. Eligibility Requirements

To qualify for the Employee & Contractor Scholarship, applicants must:

- 1. Be a **full-time employee or contractor** of Preventive Measures or any company within the PM Wellness Enterprise.
- 2. Be in **good standing** with no corrective action or suspension within the last six (6) months.
- 3. Be pursuing a **degree program, continuing education, certification, or professional development opportunity** that supports **any career goal** (not limited to the employee's or contractor's current position at Preventive Measures).
- 4. Submit a **250 500-word essay** describing the course/program of study and how it will advance their career or professional development.

## 4. Funding & Payment

- Scholarship funds may be paid directly to the school or company through invoice or wire transfer where possible.
- If direct payment is not possible, the employee/contractor must pay out of pocket and submit valid receipts for reimbursement up to \$1,000.00.
- Scholarship funds must be used exclusively for tuition, certification fees, continuing education, or other approved professional development costs.

#### 5. Terms & Conditions

- 1. Scholarship funds are intended to **enhance the professional and career growth** of employees and contractors of Preventive Measures and the PM Wellness Enterprise.
- 2. If the employee or contractor **terminates employment or contract** with the organization within six (6) months of receiving the scholarship funds, they are required to repay the full amount awarded.
- 3. PMF reserves the right to **approve or deny** scholarship requests at its sole discretion based on available funding and alignment with the applicant's stated career development goals.
